

## **FEES FOR REPORTS AND SERVICES**

**WEB ACCESS – “Real-time” 24 x 7 information, updated every 15 minutes, is available on our website: [www.mxsocal.org](http://www.mxsocal.org).** (Available by subscription and/or credit card).

### **A01. IMPORTANT NOTICE**

All **new** subscribers will be billed a **non-refundable, Set Up/Administrative Fee** ..... **\$100.00**

Note: **Current** subscribers wishing to add additional reports/services are **not** required to pay an additional Set Up Fee

### **A02. SUBSCRIPTION DISCOUNTS**

1. Advanced Quarterly Payment Discount..... 5%
2. Advanced Semi-annual Payment Discount ..... 7%
3. Advanced Annual Payment Discount ..... 10%
4. All non-profit/charitable and religious organizations in the harbor area – that provide services and facilities for visiting seamen from vessels docked or anchored in port – shall be granted a **50% discount** for Reports and Services requested ..... 50%

### **A03. EXPRESS SERVICE FOR REPORTS**

Reports will normally be sent by U.S. mail at no additional charge. However, if the Subscriber would prefer to receive Report(s) by fax, e-mail, or have web access, this fee will be applied in addition to the fee(s) for the Report(s) requested.

### **A04. MESSENGER SERVICES**

Subscribers may request their Reports (s) to be hand-delivered by the Marine Exchange – in the immediate Harbor Area only – and this fee will be applied in addition to the fee(s) for the Reports(s) requested. We offer one delivery per day..... **\$50/Month**

**R01. VESSEL ADVANCE ARRIVAL REPORTS**

- 1.** Vessel Advance Arrival Report ..... **\$60/Month**
- 1W.** Vessel Advance Arrival Report Web Access..... **\$10 Additional/Month**
- 2.** Vessel Advance Arrival Report with Lloyds numbers ..... **\$75/Month**
- 2W.** Vessel Advance Arrival Report with Lloyds Numbers Web Access  
..... **\$10 Additional/Month**

These popular reports cover an average of 4-5 days, and are published and distributed every afternoon. All vessels scheduled to arrive at POLA/POLB are listed by name – along with their flag, call sign, propulsion, type, last port of call, purpose of visit, agent, ETA (hour and date), and the anticipated berth or anchorage assignment.

- 3.** Extended Vessel Advance Arrival Report..... **\$75/Month**

The “Extended Vessel Advance Arrival Report”, covers all anticipated arrivals up to eight weeks hence.

**R02. ACTIVE VESSELS IN PORT REPORTS**

- 1.** Active Vessels in Port Report (sorted by ship name)..... **\$50/Month**
- 1W.** Active Vessels in Port Report Web Access (sorted by ship name)  
..... **\$10 Additional/Month**
- 2.** Special Active Vessels in Port Report (sorted by arrival time)..... **\$50/Month**
- 2W.** Special Active Vessels in Port Report Web Access (sorted by arrival name)  
..... **\$10 Additional/Month**

This useful report lists ALL commercial vessels in port for any given day, showing their name, berth or anchorage assignment, actual arrival and estimated departure dates, vessel operator, last port/next port, and other pertinent information. Hard copies are produced twice daily – at 0700 and again at noon.

**R03. VESSELS DUE TO SHIFT / SAIL REPORT**

- 1.** Vessels Due to Shift / Sail..... **\$30/Month**
- 1W.** Vessels Due to Shift / Sail Web Access ..... **\$10 Additional/Month**

This report is produced daily, showing ALL commercial vessels scheduled to depart from LA/LB Harbor that day, and the next. Included are the names of the vessels, flag, propulsion, berth or anchorage assignment, destination, and their ETD (by hour and date). On “Shifts” within or between POLA/POLB, the vessels are identified by name, along with their flag, propulsion, type, current berth or anchorage assignment, the scheduled time for shifting, and their new berth or anchorage assignment after the shifts.

**R04. DAILY ARRIVAL / DEPARTURE / SHIFT LOGS**

- 1. Daily Arrival / Departure / Shift Logs ..... **\$60/Month**
- 1W. Daily Arrival / Departure / Shift Logs Web Access..... **\$10 Additional/Month**

These reports are published each morning, covering the previous day’s ACTUAL vessel arrivals, departures, and shifts (from 0000 to 2400). Listed are the vessel’s name, operator and agent, net tonnages, last port of call, next port of call, flag, LOA, type, propulsion, and berth or anchorage assignments.

**R05. BROKER’S REPORT**

- 1. Broker’s Report..... **\$50/Month**

This report comes out each morning and lists all arrived vessels (from 0700 to 0700 hours) scheduled to discharge cargo in foreign commerce. Broker’s Report shows flag, propulsion, type, call sign, agent, time, berth or anchoring location and port of call.

**R06. HARBOR VESSEL TRAFFIC UPDATE REPORT**

- 1. Harbor Vessel Traffic Update Report ..... **\$60/Month**
- 1W. Harbor Vessel Traffic Update Report Web Access..... **\$10 Additional/Month**

This report summarizes a “snapshot” of the traffic expected in the port for the current day and the next three days. It provides a total vessel count and a container vessel breakout for each of the following:

- Vessels currently in port
- Vessels scheduled to arrive
- Vessels scheduled to shift
- Vessels scheduled to depart

**R30. TUG OPERATORS’ SERVICE PACKAGE**

- 1. Tug Operators’ Service Package ..... **\$300/Month**

This bargain package includes the following reports and services, sent by fax or e-mail each day:

- Vessel Advance Arrival Reports (daily)
- Active Vessels in Port Reports (daily)
- Vessel Advance Sail/Shift Reports (daily)
- Tug Assist/Escort Reports (bi-weekly)
- Daily Arrival /Departure/Shift Logs
- Telephone Notification on All Arrivals

- 2. Tug Operators’ Service Package Enhanced Confidential..... **\$320/Month**  
Includes the ‘Confidential’ versions of the above reports.

**M101. MONTHLY COMPOSITE REPORT**

- 1. Monthly Composite Report..... \$50/Month**

This report is published and distributed during the first week of each month, and lists the total arrivals and departures for the previous month, plus a “year-to-date” total composite. The report also lists arrivals by flag for the month, as well as a breakdown of arrivals by type of vessel. Total bunker jobs for each port are listed separately. Comparisons are made between the current month and previous month, as well as between the current month and the same month of the previous year.

**Monthly Complete Package Report also includes the following:**

**VESSEL BUNKERING REPORT:**

Shows all “bunkering only” activity for the month by port, including previous year’s stats.

All “bunker only” statistics reflect ships taking fuel when anchored.

**ARRIVALS BY FLAG:**

Lists a breakdown of all arrivals by flag of registry. Year-to-date totals shown.

**ARRIVALS BY SHIP TYPE AND AGENT/OPERATOR:**

Tabulates totals of all arrivals by ship type, as well as by agent and/or operator.

**ARRIVALS BY SHIP TYPE:**

Documents all arrivals with a break-down by vessel type only. (Including previous year’s stats).

**ARRIVALS BY COMPANIES:**

Reports total MONTHLY arrivals for each agent and/or operator; with year-to-date totals shown.

**ARRIVAL SUMMARY:**

Shows a monthly total for all arrivals, by year, with comparisons running back for a 10-year period. (We can also provide a “total monthly re-cap” on all the arrivals dating back to 1923).

**T01. TELEPHONE REPORTS (ANY BUSINESS)**

- 1. Telephone Reports..... \$75/Month**  
**1A. For subscribers receiving one or two of our reports..... \$60/Month**  
**1B. For subscribers receiving three or more of our reports..... \$50/Month**

This service includes calls made by the Marine Exchange to announce all (or particular) arriving vessels as requested by the Subscriber, as well as WHEN such calls are to be made, and to WHOM. We can also page Subscribers on their “beepers”, or fax and e-mail them at their office with this information.

Additionally, Subscribers to this service may elect to call into the Marine Exchange daily, seeking basic information by telephone on vessel arrivals, departures, shiftings, berth/anchorage assignments, and other such data.

**S01. "SPECIAL REPORTS" (Ad Hoc)**

1. Special Reports.....**Negotiated Fee**

**S02. NEWSPAPER REPORTS PACKAGE**

1. Newspaper Reports Package ..... **\$300/Month**

- Sail/Shift Report
- Telephone Call-In Service for Update Info (24 hours)

**S03. MONTHLY DATABASE ACCESS REPORTS**

1. Monthly Database Access Reports..... **\$300**

Subscribers to this Service may request a manipulation of the MX computer database, to provide statistical information of almost any sort and variety. We can translate any info into many different formats (Web Service, XML, ASC-II Text, any Microsoft Office format, etc.) for use in a variety of other computer software formats.

**S04. REPRODUCING ARCHIVED MATERIALS**

1. Reproducing Archived Materials.....**Negotiated Fee**

The Marine Exchange has access to most of the daily, monthly, and annual reports listed herein, for the current year and three years prior. Subscribers may order back copies of some reports. Check with MX for availability and pricing

**S05. ABSTRACTING AND COMPILING INFORMATION FROM ARCHIVES**

1. Abstracting and Compiling Information from Archives.....**Negotiated Fee**

If specific information is required that may not be included on the reports above, or if information is needed prior to our computer automation (years 1923 – 1993) a solution can be found using MX staff or your own staff. Check with MX for details and pricing.

**TARGET Target Mapping**

Views of the vessel traffic in the Marine Exchange’s Area of responsibility. It includes vessels tracked by radar as well as vessels equipped with various types of Automatic Identification System (AIS) transponders.

Non subscribers..... **\$150/Month**
